Investment approach

- Seeks to track the performance of the MSCI US Investable Market Consumer Discretionary 25/50 Index.
- Multicapitalization equity in the consumer discretionary sector.
- Employs a passively managed, full-replication strategy when possible.
- If regulatory constraints prevent full replication, the fund uses a sampling strategy to approximate the index's key characteristics.
- The fund remains fully invested.
- Low expenses minimize net tracking error.

About the benchmark

- The MSCI US Investable Market Consumer Discretionary 25/50 Index includes stocks of U.S. companies within the consumer discretionary sector.
- The sector is made up of manufacturing and service industries that tend to be the most sensitive to economic cycles, such as automotive, apparel, leisure equipment, hotels, restaurants, and consumer retailing.
- Uses GICS methodology and clearly classified sectors.
- Offers broad representation of the target sector across large-, medium-, and small-cap companies.

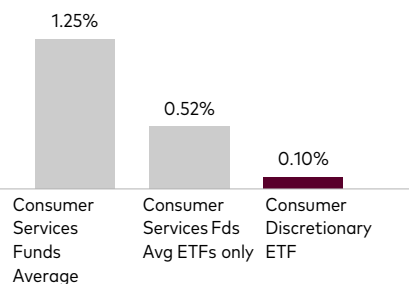
